What is Age Matters ACH Program?

Age Matters ACH Program offers supports to low-income seniors whose living situation is not secure, who are homeless or are at risk of becoming homeless.

Assistance with Care & Housing

Through the ACH Program, Coordinators link seniors to suitable community services and work with them to find sustainable and appropriate housing they can afford.

This support includes:

- Locating suitable and affordable long-term housing
- Providing advice and assistance with housing applications
- Help to access legal and financial services related to housing
- Assistance with packing & moving seniors into their new homes
- Advocating & linking to services including Aged & Community Care, welfare and disability supports

Age Matters ACH Program clients receive tailored assistance that suits their needs.

Fees & charges

The service is free for eligible clients.

Funding

The ACH Program is funded by the Department of Health.

Follow-up support

Age Matters ACH Program does not provide ongoing care. However, it does provide short-term follow-up support, where appropriate, enabling clients to continue living in their accommodation or community setting.

Availability

These services are available in the Illawarra & Shoalhaven regions.

Eligibility

Assistance is available to seniors who are:

- Living on low incomes
- Homeless or at risk of becoming homeless
- Frail and aged 65+ or prematurely ageing and aged 50+
- Aboriginal and Torres Strait Islander aged 45+
- Living in insecure housing
